### *From the President's Corner...*

It's been a busy time with the Friends. There is much business news this month, and there are lots of internal changes happening, mostly concerned with transforming the organization into a corporation. At the last membership general meeting in January, a resolution was passed to take this step. There are a number of benefits in doing so, but the downside is a bit more formality and paperwork. While various parts of the process are still in progress, the basic step is done. We have been granted corporation status by the Commonwealth of Virginia. The formal name is *Friends of the Mathews Memorial Library, Inc.*

At the moment, there are two organizations existing side by side – the old Friends organization and the new Friends corporation. The old Friends continue to hold the assets. The reason for this is that we are applying for tax exempt status 501(c)(3) for the corporation. The old Friends has that status already. Once the corporation is granted tax exempt status, our assets will be transferred to the new corporation, and the old organization will be dissolved. Kind of “switching horses in mid-stream.”

All of this takes various resolutions and filings, and we owe a debt of gratitude to Jim Hutchins, our new very busy Treasurer who is working hard and using his long legal experience to good effect. It's hard to know how we would have gotten it all done without his expertise and efforts.

## CRITICAL CONVICTIONS

Can anyone convey, with a modicum of objectivity, what impact a book will have on those who read it? Do reviews provide the means by which to convey a sense of how a reader will respond? Words, sentences, and paragraphs are dynamic elements that may reach to the depth of an individual's soul to reveal some inner truth or inflame passions that drive them to imprudent action.

The uncomfortable truth is that it falls to public library staff members to reflect upon, and choose, those works of literature that grace the shelves of libraries and thus become accessible to a diverse group of patrons from all walks of life. Guided by policies that are broad and funding that is generally limited, experience and knowledge of community culture and interests become the tools of choice in collection development. Even so, librarians frequently experience moments of discomfort when items in the collection are called into question.

It is, however, a basic tenet that, although frequently under attack, the freedom to read is essential to our democracy. Throughout our history, reading is perceived to be among our greatest freedoms. The written word is the natural medium for new ideas and the preservation of a free society. Further, the freedom to read is guaranteed by the constitution. In light of the importance of this basic right and because of the significant role that libraries play in preserving it, the American Library Association (ALA) has adopted a "Freedom to Read Statement." Included in the seven propositions of the Statement are the following:

*It is in the public interest for publishers and librarians to make available the widest diversity of views and expressions, including those that are unorthodox, unpopular, or considered dangerous by the majority.*

*Publishers, librarians, and booksellers do not need to endorse every idea or presentation they make available. It would conflict with the public interest for them to establish their own political, moral, or aesthetic views as a standard for determining what should be published or circulated.*

*It is the responsibility of publishers and librarians to give full meaning to the freedom to read by providing books that enrich the quality and diversity of thought and expression.*

## The State of Electronic Books & Readers

It's enough to make one's head spin and to just buy a good, inexpensive used printed-on-paper book from the Friends used book sale! The world of electronic books and e-book readers has exploded in the last couple of years. This Christmas season, Amazon.com reported that for the first time, sales of electronic copies of books exceeded sales of traditional printed books. It's a brave new book world. Most of us in the Friends being born, shall we say, before a certain date, will never use or be comfortable with e-books and e-readers, but the digitally-oriented young are taking to the idea in droves.

A good review of e-readers one can purchase for reading e-books is on that old standby, Wikipedia. Take a look at [http://en.wikipedia.org/wiki/List\\_of\\_e-book\\_readers](http://en.wikipedia.org/wiki/List_of_e-book_readers). There you'll find listed 31 different readers by 16 different providers. One of the latest of the big guys is Barnes & Noble's *Nook* reader. Like Amazon's *Kindle* and Sony's *Reader*, one can download books in a minute or so. You have to either have contact with an AT&T cell phone tower, or be in range of a wireless hot spot such as the Library's. New books and best sellers cost \$9.99, and old titles vary in price and are less. How about *War and Peace* for \$0.99? Barnes & Noble says that thousands of their e-books are free.

The number of books you can have on a *Nook* reader is staggering. It will hold about 1500 average books! That should be plenty to read over a really long vacation! It provides the ultimate in consolidating luggage space when traveling. It is 8" x 5" x 1/2" thick, and weighs under 3/4 pound. Fold an 8 1/2 x 11 sheet in half, and that's about the size.

How about needing a book while you're traveling in Timbuktu? There surely must be a Starbucks

around (aren't they everywhere?) or some other wireless spot that you can use to connect to Barnes and Noble's eBook store. In a minute you've got another book to read if none of the 1500 in your *Nook* appeals to you at the moment.

There's even a way to lend e-books to friends. You can lend a book for up to 14 days, and it will be readable on the friend's reader, but not on yours for the durations of the loan. Actually this concept is broader than B & N's *Nook*. Some libraries are using a similar feature to lend library books to patrons. You check it out and it disappears from the library's e-book "shelves" for the checkout period. The books can be read on your computer, iPhone, or Blackberry, so you're not limited to the *Nook*.
